## Classes

- This Match will be held under AKC Rules and Regulations.

- Conformation classes are open to dogs that are not champions of record.
- Classes will be divided by sex. Dogs competing in conformation as adults must be one year of age.
- Conformation classes are 3-6mos., 6-9mos., 9-12mos., Open.
- Juniors Classes are Novice Junior, Intermediate, and Senior Open Junior, Intermediate, and Senior
